Lane Parke does have some restrictions due to the current tenant mix, therefore Lane Parke management may deny applications. Accepted applicants will be notified regarding the status of their application within one week of submitting.

All vendors are responsible for providing tents, tables, linens, and any other items needed for the pop-up. One 10x10 space will be assigned per vendor unless additional space is requested. All vendors are responsible for the setup and breakdown of space and electricity is not available on-site. Generators are allowed but must be silent.

Vendors must have a city of Birmingham or Mountain Brook business license and attach a copy with the application.
